**REVISED DRAFT ENVIRONMENTAL IMPACT ASSESSMENT REPORT FOR  
 PUBLIC REVIEW AND COMMENTS**

A Draft Environmental Impact Assessment Report (EIR) was distributed for public review from 06 March to 30 June 2010. Upon receipt of comments from Interested and Affected Parties (I&APs) a number of specialist reports and the Draft EIR was revised.

Comments received on the Revised Draft EIR will be used to produce the Final EIR, which will then be submitted to the DEA for their consideration. A letter will be sent to all registered I&APs informing them of the Authorities' decision.
